

Coronavirus Aid, Relief, and Economic Security (CARES) Act Emergency Grant Quarterly Reporting:

In accordance with being a CARES Emergency Grant Recipient, Chesapeake College has continued to pay all of its employees and contractors during the period of any disruptions or closures to the greatest extent practicable. We are committed to supporting our student, staff/faculty safety and success.

Section 18004(c) of the CARES Act allows Chesapeake College to use up to 50 percent of the funds received to cover any costs associated with significant changes to the delivery of instruction due to the coronavirus so long as such costs do not include payment to contractors for the provision of pre-enrollment recruitment activities, including marketing and advertising; endowments; or capital outlays associated with facilities related to athletics, sectarian instruction, or religious worship (collectively referred to as "Recipient's Institutional Costs"). Section 18004(c) also requires Chesapeake College to use no less than fifty percent of the funds received to provide emergency financial aid grants to students for expenses related to the disruption of campus operations due to the coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and child care). This Certification and Agreement solely concerns Chesapeake College Institutional Costs, as defined above.

Chesapeake College has received \$458,767 to issue Emergency Grants to Students. We intend to use no less than 50 percent of the total funds received to offer Emergency Grants to students. Chesapeake College has received \$458,767 of Emergency Institutional Grant funding to pay for Coronavirus related expenditures to train faculty and staff for online learning, enhance online technology for students and provide for a safe and clean environment on campus. The College transferred \$148,751 of Institutional funds to be used for student awards in January 2021.

Chesapeake College has received \$458,767 to issue emergency grants to students under the new (December 27, 2020) Higher Education Emergency Relief Act (HEERF II) grant. In addition, Chesapeake College has received \$1,676,381 of emergency institutional grant funding for COVID-19 related expenditures to train faculty and staff for online learning, transition/develop formerly face-to-face classes to online, enhance online technology for students, provide for a safe and clean environment on both our Wye Mills and Cambridge sites and recoup lost revenue due to COVID-19.

Chesapeake College has received \$1,901,887 to issue emergency grants to students under the new (May 12, 2021) American Rescue Plan (HEERF III) grant. In addition, Chesapeake College has received \$1,798,464 of emergency institutional grant funding for COVID-19 related expenditures to train faculty and staff for online learning, transition/develop formerly face-to-face classes to online, enhance online technology for students, provide for a safe and clean environment on both our Wye Mills and Cambridge sites and recoup lost revenue due to COVID-19. A CARES Committee organized and meets monthly to review the allocation of the institutional funds, to maintain compliance with the grant specifications and provide guidance for the greatest impact on the needs of our students, faculty and staff.
