When possible, employees should work alone in a building or area. Employees should always avoid coming within six feet of another person. Employees should always wear a face covering unless working alone in a private office. ** • Mail, shipping & receiving will occur at a central location for pick-up. • All business travel must be approved by a Vice President. <p><u>Engineering Controls</u></p> <ul style="list-style-type: none"> • All buildings secured to prevent unauthorized access. • Workspaces altered for those departments coming to campus for essential tasks. • Routine disinfection/sanitation of high-touch common areas accessed by employees. • Minimal campus presence in any location. • Signage posted to ensure students and employees are aware of controls and procedures <p><u>PPE</u></p> <ul style="list-style-type: none"> • All persons on campus must wear a face covering unless alone in a private office. ** • May be additional requirements for specific locations/classrooms. <p><i>**Face covering (facemask) must adequately cover the nose and mouth so as to prevent the transmission of respiratory droplets.</i></p>

When approved by VP WFAP, delivery of essential face-to-face courses, including Skilled Trades, where hands-on activities are required. <p><u>Students</u></p> <ul style="list-style-type: none"> Unless approved by the VP WFAP, remain off-campus and served via remote instruction and student services. Food service remains closed. With approval by Athletic Director, student-athletes may have limited access to athletic fields and facilities while following physical distancing protocols. <p><u>Campus / Public</u></p> <ul style="list-style-type: none"> Campus open with single-point check-in. Fitness Center, gymnasiums, athletic fields remain closed. Outdoor facilities open for physically distanced recreation. 	<p><u>Physical Distancing</u></p> <ul style="list-style-type: none"> All persons on campus must practice physical distancing consistent with CDC recommendations. All persons on campus must wear a face covering unless they are alone in a private office. ** Access to campus remains limited by appointment. <p><u>Administrative Controls</u></p> <ul style="list-style-type: none"> All classes that can be delivered effectively online shall remain online only. Limited course offerings may be delivered face-to-face (in full or only partly) upon recommendation of the VP WFAP and President's Cabinet, for example Health Professions and Skilled Trades. In-person classes will be physically distanced according to Engineering Controls below. Non-critical individuals will require special permission from a Vice President and coordination through Public Safety to enter campus, with specific location access only. Number of open buildings is limited. Congregation inside and outside is not permitted. Mail, shipping & receiving will occur at a central location for pick-up. All business travel must be approved by a Vice President. <p><u>Engineering Controls</u></p> <ul style="list-style-type: none"> All buildings not granting student access shall be secured to prevent unauthorized access. All buildings maintain a single point of entry (locked or unlocked) equipped with sanitation stations. Access restricted to unused building sections. Workspaces altered for those departments coming to campus for essential tasks. This includes laboratories and classrooms as necessary. Routine disinfection/sanitation of all utilized classrooms, offices and high-touch common areas accessed by students or employees. Maximum of 10 persons in a room or 50% capacity if state-compliant physical distancing can be achieved. Routine disinfection/sanitation of all utilized classrooms, offices and high-touch common areas accessed by employees. Maximum of 10 persons in a room or 50% capacity if state-compliant physical distancing can be achieved.
