Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA)

Through CRRSAA, Chesapeake College is authorized to award Higher Education Emergency Fund (HEERF) II grants to students.

Chesapeake College identifies recipients who are potentially eligible. We estimate 647 potentially eligible students.


We perform direct outreach to our students informing them of funding availability. We have a direct webpage to inform students that these resources are available. Students can also request funding from this page as well.

Institutional leadership has determined that funding will be available for degree seeking students, continuing education, students, and dual enrollment students. We determine the maximum awards by evaluating the amount of funding available and the total number of our unduplicated Pell Recipients. For tuition payments, students receive up to 50% of the amount of their total bill. When appropriate, we make professional judgment decisions and evaluate amounts received on a case by case basis.

Grant Distribution to Students

Once the student returns the request form, they are evaluated and awarded accordingly. This process does not exceed **7-10** business days. Once awarded, the direct payments are disbursed to an account maintained solely for HEERF grant distribution. The full amount of the award is mailed directly to the student via check within **7** business days. Direct payments and tuition and fee payments will be released after the add/drop period for the current term. Once awarded, students are sent these communications:

You have been approved to receive the direct payment through the Higher Education Relief Fund (HEERF II) for the **Fall 2021 term**.
