

Phased Reopening Guidelines

Phase RED

Maryland Stay at Home Order

Campus Fully Closed & College Operating Exclusively Online.

Phase ORANGE

Only LOW Risk Activities Permitted

Students

- Student instruction delivered remotely, with limited exceptions for Health Professions, or as approved by VP Workforce and Academic Programs. Consult instructor for specific details.
- Student Services offered remotely; in general, students remain **off-campus**.
- Food Service, Fitness Center, LRC, Athletic Fields, Bookstore, and TPAC remain closed.
- May be additional requirements for specific locations/classrooms.

Campus/Public

- Campus open to essential personnel only, and those with VP approval.
- Campus grounds and buildings are CLOSED to the public.
- Events: No in-person, college-hosted events.

PPE & Physical Distancing

- All persons required to follow PPE protocols based on state and local mandates. Unvaccinated individuals are strongly encouraged to continue to wear an appropriate face covering.**
- May be additional requirements for specific locations/classrooms, abide by posted signage.
- Visitors use single point-of-entry at Rt. 213, main entrance, subject to screening process. Complete online screening at www.chesapeake.edu/cars.

Phase YELLOW

Some MEDIUM Risk Activities Permitted

Students

- Student instruction delivered remotely, with limited exceptions for Health Professions and Skilled Trades, or as approved by VP Workforce and Academic Programs. Consult instructor for specific details.
- Student Services offered remotely; in general, students remain **off-campus**.
- Food Service, LRC, Bookstore, and TPAC remain closed.
- With approval by Athletic Director, student-athletes may have limited access to athletic fields and facilities while following physical distancing protocols.

Campus/Public

- Campus open to personnel or students with approval.
- Campus buildings, Fitness Center, LRC, Bookstore, and TPAC remain closed to the public.
- Outdoor facilities open for physically distanced recreation; congregation indoors or out is not permitted.
- Events: Extremely limited in-person, college-hosted events, requiring Presidential approval.

Phase BLUE

Additional MEDIUM Risk Activities Permitted

Students

- Student instruction delivered remotely, with additional capacity for exceptions as approved by VP Workforce and Academic Programs. Consult instructor for specific details.
- In-person classes will be subject to additional safety protocols.
- Open with limitations: Student Services, Fitness Center, Food Service, LRC, Testing Center, and Bookstore.
- College athletics continues based upon NJCAA guidelines.

Campus/Public

- Campus buildings begin opening with limitations.
- Outdoor facilities open for recreation and congregation, with adequate protocols and physical distancing.
- Events: Limited in-person, college-hosted events, requiring Presidential approval.

Phase GREEN

HIGH Risk Activities Permitted

Students

- Students, athletes, coaches, and College personnel resume in-person interactions with published protocols and Action/Controls as detailed.
- Ongoing messaging based on recommended guidelines and administrative controls.

Campus/Public

- Unrestricted access to campus based on published protocols.
- Events permitted on campus.
- Some physical distancing and risk mitigation controls may need to be implemented on a case-by-case basis based on CDC, state or local guidelines, with appropriate signage.
